- 3. Secretary General, Shri S S Kulkarni, extended a warm welcome to the IDST members.
- 4. Sec Gen briefed the members on AGM agenda points and invited President IDST Shri Purna Darapuneni to deliver opening address.

Address by the President IDST

5. During his address, on behalf of the Central council of the Institute he congratulated all the members on the completion of one year very successfully. He further added "I am glad to report that overall growth of the Institute is appreciable. All details are being presented by the Secretary General and Chairman Finance. Administration of all the branches, enthusiasm and zeal of the PIs and support of active members, in particular, is commendable"

Today we are a strong family of 1542 registered members resulting to 1340+ active members with growth of around 45-50 members every year. 71 running CAPSIs valued at around Rs 1650/- lakhs and 80+ PIs engaged on these CAPSIs. Our Income over expenditure has **enhanced to Rs 57.56 Lakh from Rs 43.89 Lakh** last year.

6. Training/Seminars/Workshops

As regards Training activities, IDST Hyderabad Branch conducted courses for BEL Bangalore on various Technical subjects and a one day symposium on Electronic Warfare Modeling and Simulation in association with ANSYS Systems. A two-day Conclave on Autonomous Technology and Systems (CATS 2024) was organized by IDST Pune in association with R&DE(E), Pune on 11 & 12 Jan 2024 at Dr. APJ Abdul Kalam DRDO Golden Jubilee Auditorium. An exhibition for display of products was arranged in which 26 trade and DRDO establishments participated. Conclave and Exhibition inaugurated by Dr. SV Gade DG (ACE) and Dr. Makrand Joshi Director R&DE (E) was guest of honor. Around 140 delegates attended the seminar.

7. Breakthrough in the field of Academics

(i) M Tech Defence Technology course launched by DRDO & AICTE has commenced at Amrita Vishwa Vidyapeetham, Coimbatore & Manipal Institute of Technology, Manipal, Cochin University of Science & Technology, Cochin, Veer Jijamata Technical Institute (VJTI), Mumbai and DKET Ichalkaranji, (Maharashtra). First Batch of 83 student is passing out now, whereas second batch of 45 students is undergoing dissertation/ projects at various DRDO labs. Third batch has commenced in this academic year.

8. IDST Website

- a. IDST Web site provides information of IDST functioning as well as details of members along with their expertise. Website has been updated regularly.
- b. Website is very effective for election process. For Regional council & Central council During Oct 24, Elections were conducted very effectively. Online membership process is now stabilized. In this calendar year 51 new members were enrolled online.
- c. Overall administration at all levels has been fair. All meetings & interactions

were held virtually, holding elections on line, availing net banking facility for all transactions and putting continuous efforts to migrate to paperless office. Thanks to all concerned for their efforts.

d. IDST is extremely thankful to our Patron, Chairman DRDO Dr Sameer Kamat G. Satheesh and DRDO nominees to the Central Council Dr Subrata Rakshit, DS & DG (TM), and Ms. U Jeya Santhi, OS & DG (HR) for their constant guidance and support for overall growth of our Institute. Thanks are due for the confidence shown in IDST by giving the responsibility for conduct of "M Tech Course in Defence Technology" at various educational Institutes. We express our sincere thanks and gratitude to DRDO, our parent Organization and reassure our services for all times in future.

- a. In additional to the above statutory audit by CA, Internal System Audit of all the branches have been completed satisfactorily. No irregularities were observed,
- b. SecGen further informed the house that M/s RMC Associates CA, Delhi has intimated vide their letter no Service Quote: 2023098 dated 15 Nov 2024 & agreed to carry out the IDST audit for FY 2024-25 with the same terms & condition that of previous year for Audit Fee of Rs 1,15,000/- + GST & Logistics (for Travelling exp to visit various branches) expenditure on actuals or Rs 37,000/- whichever is less.
- c. Following resolution was passed:
- "Resolved that AGM-21 approved the Audited Statement of account for FY 2023-2024. AGM approved appointment of CA M/s RMC Associates Delhi, for the Audit of IDST accounts of all four IDST branches & IDST HQ for FY 2024-25 with financial limit of Rs 1,15,000/-+ GST for Audit and TA/DA at actuals and not exceeding Rs 37,000/-."
